9.2 Agreement on the operation of a Level 3 first responder service

WHEREAS for the purpose of setting up a first responder service (hereafter called PR) on its territory, the CIUSSS of the National Capital must enter into an agreement with the Municipality in accordance with section 38 of the Services Act (RLQ, Chapter C-69, hereafter called LSPU);

WHEREAS the above-designated service must be accredited by the CIUSSS of the National Capital in accordance with Section 38 of the LSPU;

WHEREAS the Municipality wishes to maintain the Level 3 PR service established on its territory in accordance with the LSPU;

WHEREAS the above-designated service is accredited by the CIUSSS of the National Capital in accordance with Section 38 of the LSPU;

WHEREAS the National Capital CIUSSS must recognize, based on national standards established by the Ministry of Health and Social Services (herefater called Minister), organizations that can provide PR training;

WHEREAS the CIUSSS of the National Capital wishes to standardize the agreements and memorandums of understanding reached with municipalities in its territory regarding the implementation and operation of PR services;

WHEREAS a PR, under the exclusive condition of the Health Communication Centre, provides a person whose condition requires the required first responder stabilization assistance in accordance with the Clinical Intervention Protocols for first responders, developed for this purpose by the Minister and corresponding to the level of training he recognizes;

AND UNANIMOUSLY RESOLVED:

To authorize Mayor Brent Montgomery to sign the Agreement for and on behalf of the Municipality regarding the operation of a Level 3 First Responder Service. The purpose of the agreement is to define how PR Level 3 services operate, the quality standards that must be met, the funding terms, if any, and the terms of reimbursement of expenses deemed eligible, the terms of the accountability as well as the cases, conditions and circumstances for which either Party may terminate the agreement. More specifically, this agreement aims to define the respective obligations and rights of the Parties with respect to the training required to maintain the Municipality's Level 3 PR accreditation including any training that would be required, notably as a result of an amendment to the Clinical Intervention Protocols for First Responders (PIC-PR).

10. PUBLIC WORKS AND HYGIENE

10.1 Report from the person responsible for Public Works - Mr. Dany Laberge

Mr. Dany Laberge reports on the activities of the Public Works Department. Here are the main topics:

Water meters:

The installation of water meters in farms, businesses and institutions fed by the aqueduct system is complete. The work was carried out by the contractor MG2 Energy.

Walking trail:

The extension is scheduled to open in early August. The paving and lighting will take place in a later phase.

Stabilization of the banks of the Jacques Cartier River on Redmond Road:

Due to the spring flood in the Jacques Cartier River, a section of riverbank along Redmond Road was eroded by the current. Signs of settlement began to appear in the shoulder of Redmond Road for a distance of a few dozen metres. In order to prevent this situation from worsening, the Municipality has enlisted the services of a professional firm to explore the various possible avenues that will help to secure the stability of Redmond Road. Given the number of stakeholders in this matter and the painstaking process for shoreline work, Mr. Laberge informed the members of the council that he would make a temporary repair to solidify the shoulder.

Replacement of culverts on Caroline Street:

In February 2019, the Municipality awarded a contract to Stantec for the preparation of plans and specifications, cost estimates, tendering process and bid analysis for the replacement of the Caroline Street culvert. The tender documents were submitted to the Municipality for comment on July 8, 2019. A public tender will be launched in the coming weeks for the work to be completed in September 2019.

Mowing of roadsides:

The mowing of roadsides will be performed during the week of July 15, 2019.

10.2 Awarding of contract for the removal and replacement of a section of the wooden decking on Clark's Bridge

As a result of a request for bids to replace a section of the Clark's Bridge wooden decking, no bids were received.

The following contractors were invited to submit a bid:

It is concluded to request bids for this project and to evaluate the possibility of not going to bid as the project amount involves an expense of less than \$58,000, including taxes.

11.4 Minor derogation - lot 2,196,465

This minor derogation is to confirm the issuance of a permit for a future construction of a commercial building where the rear margin of the building would be 2 m from the property line instead of 7.5 m according to the by-law currently in force.

To accept the request for a minor derogation for lot 2,196,465 of the official land registry of Saint-Gabriel-de-Valcartier in order to confirm the issuance of the future building permit with a rear setback 2 m from the property line instead of 7.5 m, as recommended by the CCU.

12. RECREATION, CULTURE AND COMMUNITY LIFE

12.1 Report from the Sports and Recreation Director - Mrs. Pamala Laberge

Mrs. Laberge submitted her report to the General Director prior to the meeting.

Here is a summary:

Financial assistance for Cultural program:

In May, the Historical Committee submitted an application to the MRC de La Jacques-Cartier as part of the "Cultural Development Agreement and Regional Cultural Fund" financial assistance program for a project, to be carried out by the Quebec Conservation

Centre, to restore an ancient map dating from 1896. The Municipality was awarded \$3,000 in funding for this project.

Summer Playground:

The Summer Playground Program began with a total of 249 registrations and 22 animators. The activities are going very well.

Heritage Celebration 2019:

The Heritage Celebration 2019 was held in Sainte-Catherine-de-la-Jacques-Cartier on June 15 and 16. The Mayor wishes to congratulate the organizing committee, among others, Pamala Hogan, Director of the Sports and Recreation Department and Mr. Dany Laberge, responsible for Public Works, who both helped to ensure the success of this event.

13. MRC AND REGIONAL DOSSIERS

Mayor Brent Montgomery informed members of council that the last meeting of the MRC Council of Mayors was held on June 19, 2019.

Here is a summary of the meeting.

 Quebec City Tourism Office: The MRC de la Jacques-Cartier has applied for a \$21,000 grant for the regional cycling path project between the Municipality of Saint-Gabriel-de-Valcartier and the Municipality of Lac Delage.
