7.1 Election of Pro-Mayor

Resolution concerning Bill 48:

WHEREAS the tabling at the National Assembly, on November 5, 2019, of Bill 48, an Act primarily aimed at controlling the cost of the agricultural property tax and simplifying access to the credit for agricultural property taxes;

WHEREAS the Bill would have the effect of limiting the agricultural property assessment;

WHEREAS the Bill will have an important impact directly to the finances of municipalities;

WHEREAS the Bill would represent an attack to municipal autonomy;

WHEREAS the Bill would create inequity between municipal taxpayers;

WHEREAS to recover lost tax revenues, municipalities should tax other classes of taxpayers more;

WHEREAS the Bill will encourage integrators and therefore the industrial agriculture model;

WHEREAS the Bill could eventually contribute to the devitalization of farming communities and thus affect land use in Quebec;

WHEREAS this Bill will not promote the development of agricultural activities, one of the foundations of the economic vitality of the regions of Quebec;

WHEREAS the Quebec government should adopt policies that promote land use rather than misguided reforms that will affect the development of the regions

The Project is carried out by ULAVAL and subsidized by the Ville de Québec.

11.3 Report from the Municipal Inspector – Mr. Stacy Gagné

Mr. Stacy Gagné summarizes the projects to be carried out in 2020:

11.4 Minor Derogation – lot 2 988 425

Mr. Stacy Gagné explains the context and nature of this minor derogation request for lot 2 988 425. This minor derogation consists in confirming the issuance of a future construction permit where the surface area of the garage will be superior to the maximum permitted in the municipal By-laws as well as the presence of two main residences on the same lot during the construction phase.

- A request for the parcelling of two lots (2 988 425 and 2 196 116) which turns out to be compliant, because they make the new lot regulatory, has been filed.
- The proprietors wish to build a new single-family residence with integrated garage on the lot.
- The proprietors will demolish the existing garage and keep the workshop (acquired right).
- The goal is to transform the old residence into a garage to store their farm equipment (tractor, lawn mower, etc.) while keeping the existing structure of the house to save on costs. The regulatory problem is situated at the level of the surface area of the future garage. In the By-law, it is permitted to have a garage with a surface area of a maximum of 30X30 (900 square feet) and this one would have an area of 39X32 (1248 square feet).
- The proprietors will keep the existing residence in place during the construction of the new residence and will then transform it into a garage when they transfer their personal effects to the new residence.
- The derogation lies in the fact that they will have two main residences on the same lot while the new residence is built and the future garage which will have a surface area of 32X39 (1248 square feet).

Resolution to the MRC de la Jacques-Cartier concerning paratransit services for 2020:

WHEREAS the MRC de la Jacques-Cartier offers a regional paratransit service on the territory of participating municipalities since September 1st, 2006;

WHEREAS the municipality of Saint-Gabriel-de-Valcartier participates in the paratransit service offered by the MRC de La Jacques-Cartier and therefore designates the MRC de La Jacques-Cartier as agent for the service offered on the territory of the Municipality;

WHEREAS tariffs are determined annually by resolution of the MRC, both for public transit and paratransit service, that the last resolution bearing No. 19099-O was adopted by the MRC

WHEREAS the 2020 budget for paratransit service adopted by the MRC on November 27th, 2019, comes to \$529,545;

WHEREAS the share for the municipality of Saint-Gabriel-de-Valcartier comes to \$22,036 for 2020;

WHEREAS participating municipalities must, before March 31st of each year, confirm their participation to this service as well as the amount of their share in order for the MRC to meet the requirements of the Paratransit Funding Program of the Quebec Ministry of Transport, Sustainable Mobility and Electrification.
