7.1 Election of Pro-Mayor

7.2 Homologation of the evaluation role for the financial year 2019

AND UNANIMOUSLY RESOLVED TO:

Homologate the evaluation role revised and deposited on December 6th, 2019, establishing the taxable evaluation value at \$473,460,200, that of the tax basis evaluation of \$ 94,730,949 on non-residential immovable included in the surtax appendix, as prepared by the Altus Group firm of appraisers. The nontaxable valuation is established at \$430,021,700.

7.3 Correction of resolution No. 101219 concerning the financial reserve in capital expenditures for 2019 projects to be completed in 2020

To bring the following correction to resolution 101219 to include the foreseen amount of \$130,000 to replace the Public Works' mobile workshop truck:

Erroneous text:

TO create a capital fund of \$ 905,850 from the 2019 general operating fund to carry out projects planned for 2019 to be carried out in 2020.

Corrected text:

TO create a fund earmarked for fixed assets of \$ 1,035,850 from the general operating fund 2019 to carry out the projects planned in 2019 which will be carried out in 2020.

7.4 Resolution regarding the support of MRCs relative to the *Engineers' Act*

WHEREAS the vast majority of maintenance costs for public roads and infrastructure such as aqueduct or sewer repairs, the replacement of culverts, are superior to \$1,000 and /or \$3,000, depending on the case;

WHEREAS maintenance works superior to these amounts require the filing of plans and specifications signed and sealed by a member of the Order of Engineers;

WHEREAS several minor works or repairs could be carried out without filing plans and specifications signed and sealed by a member of the Order of Engineers

WHEREAS the thresholds indicated in paragraphs a) and d) of Section 2 of the Engineers Act should be significantly revised upward in order to avoid additional costs for municipalities and citizens;

WHEREAS the Quebec Federation of Municipalities, with resolutions CA-2010-10-02 / 24, CA-2013-12-06 / 8 and CA-2018-04-12 / 10, claimed that Section 2 was not changed since 1973 making it unsuitable to the current municipal context, be amended to reflect this;

10. PUBLIC WORKS AND HYGIENE

10.1 Report from the person responsible for Public Works – Mr. Dany Laberge

Mr. Dany Laberge gives a verbal report of the Public Works Department's activities.

Recognition of Public Works' professionals as first responders in Quebec:

WHEREAS Public Works professionals are part of the first responders called following a natural catastrophe, bad weather and breakage of public goods;

WHEREAS Public Works management constitutes a major portion of the budgets of cities, these teams are led masterfully by experienced managers who need to deal with environmental, technical, human, and financial challenges and this, in a citizen-client context, and that recognition would allow these exceptional managers to obtain seats around strategic tables and to voice the issues that affect and impact them;

WHEREAS Public Works managers feel the need to standardize and normalize certain actions to ensure their quality and security;

WHEREAS the different Public Works Departments face significant challenges in terms of change and succession management and that recognition of the sector would make it possible to better understand the different trades that make them up, and by positioning Public Works as a recognized sector, it will be possible to adequately train resources, attract a succession of choice and keep them motivated and proud.

They possess the necessary degree of experience and have offered quality services to the Municipality in the past.

Project for micro-chalets and yurts:

Residents and owners have presented a project of micro-chalets and yurts that they wish to set up on the territory of the municipality of Saint-Gabriel-de-Valcartier, more specifically on lot 6 204 545, to rent out. The by-laws currently in force do not allow this type of installation. After examining the project, the members of the council are not favourable to the realization of this project.

11.3 Request to maintain agreement with the Department of National Defence and the École secondaire Mont Saint-Sacrement concerning the biological treatment of biting insects

WHEREAS the Municipality wishes to pursue the biological treatment of biting insects in the spring and summer of 2020;

TO ask the Mont St-Sacrement school Board of Directors to maintain the agreement set out in 2001, under the same terms and conditions as indicated in resolution 2001052205 adopted by the Mont St-Sacrament Board of Directors on May 22, 2001.

Moreover, the Secretary-Treasurer is also mandated to communicate with the Department of National Defence in order to obtain the necessary authorizations to treat part of the DDN property, and this, according to the same clauses and conditions as agreed upon in 2001.

Reflection on the economic development of the La Jacques-Cartier tourism industry:

A brainstorming meeting on the economic development of the tourism industry in La Jacques-Cartier will be held on Wednesday, February 12th, 2020, from 9 a.m. at the Manoir du Lac Delage. A representative and an elected representative of the Municipality will be present.

Cultural Financial Aid Program – birdhouses and bird feeders Project:

As part of the financial assistance program paid by the MRC de la Jacques-Cartier "Entente de développement culturel et Fonds culturel régional," the Municipality has submitted a request for the "cultural mediation event - birdhouses and bird feeders" project. The Municipality will benefit from a financial assistance of \$833.00 representing 2/3 of the cost of the project.

Cellular coverage on the territory of the MRC – Awarding of contract:

The topography of the territory means that cell coverage is deficient and even absent in several sectors of the MRC, despite the presence of telecommunications towers. The Origine company has been mandated by the MRC to map cell coverage on the territory.

MRC Certificate of Conformity:

According to Article 137.3 of the Planning and Development Act, the MRC de La Jacques-Cartier forwarded to the Municipality a certificate concerning Regulation No. 226 to amend the Construction By-law No. 150 concerning the installation and the visibility of the civic number on January 23rd, 2020.
