5. GENERAL CORRESPONDENCE AND FOLLOW-UP OF PREVIOUS MEETINGS

03-03-20 Letters from Valcartier Elementary School concerning the school zone:

WHEREAS the administration, the Board of Directors, the parents and the students of Valcartier Elementary School located at 1748 Boulevard Valcartier (Rte 371) deposited letters to the elected officials of the Municipality of Saint-Gabriel-de-Valcartier requesting their support from the Ministry of Transport to extend the school zone in front of the school;

WHEREAS a school zone is a "section of a road running along the boundaries of the land of a primary or secondary educational institution";

WHEREAS the frontage of Valcartier Elementary School is only 68.58 meters;

WHEREAS even if the police officers of the Sûreté du Québec are very cooperative in monitoring the sector and understand the problem, motorists simply do not reduce their speed or decrease it over a fairly long distance;

WHEREAS the students cross Valcartier Boulevard at the pedestrian crossing several times a week to take advantage of the activities at the Community Center located approximately 100 meters from the school;

WHEREAS public security is a priority for elected officials

AND UNANIMOUSLY RESOLVED

TO ask the Ministry of Transport to extend the school zone in front of Valcartier Elementary School located at 1748 Boulevard Valcartier (Rte 371) in Saint-Gabriel-de-Valcartier from the Community Centre parking (between civic numbers 1743 and 1745 Boulevard Valcartier) up to 1754 Boulevard Valcartier (public building);

TO ask the Ministry of Transport to install a flashing sign to attract the attention of users at the pedestrian crossing.

Dossier 422872 – Request for exclusion to the CPTAQ (Commission de protection du territoire agricole) on part of lots 2 196 882 and 4 396 680 for the development of Phase 4 of Domaine Saint-Gabriel as well as part of lot 3 693 496 for the development of Phase 3 for the Villas Saint-Gabriel project included within the protected agriculture zone:

The Municipality solicited a public meeting with the CPTAQ to present the dossier and rectify certain elements from the preliminary orientation. This public meeting will be held on March 25th, 2020 at 9:30 am at the Commission's offices.

Support request made to municipal council to decree the month of April Daffodil Month – Canadian Cancer Society:

In a letter dated February 10th, 2020, the Canadian Cancer Society invited municipalities to decree April Daffodil Month to send a message of hope to all persons touched by cancer.

WHEREAS each year, over 55 000 Quebecers receive a cancer diagnosis, and that this represents a major shock which affects all spheres of their lives;

WHEREAS for each affected person, one to three people around him will take on the role of caregiver;

WHEREAS about four out of ten cancers can be prevented by adapting a healthy lifestyle and implementing health policies that protect Quebecers;

WHEREAS survival for all cancers combined has increased by 8%, from 55% in 1992 to 63% in 2019, and it is thanks to the funding of innovative research that we have achieved this and that we can continue our objective of a world without cancer;

WHEREAS the Canadian Cancer Society is the only national charity that helps all Quebecers with all types of cancer and their loved ones, through research, prevention, access to a network of help, information based on the latest evidence and advocacy;

WHEREAS life is bigger than cancer, it's not just a diagnosis. To chemotherapy. To scars. The Canadian Cancer Society, through its programs, helps Quebecers build relationships with others and provide them with a quality of life and well-being;

WHEREAS April is known as Daffodil Month, that it brings hope and that the Canadian Cancer Society encourages Quebecers to take a significant action for people affected by cancer;

9.2 Action priorities for police service

Each year, the Public Security Committee of the MRC de La Jacques-Cartier identifies Action priorities regarding police services in connection with citizens' preoccupations in their living environment. Here are the 2020 Action priorities that the Municipal Council has identified for the territory of Saint-Gabriel-de-Valcartier.

- Interventions at the Teen Club youth center, in schools and in municipal parks, by raising awareness about drugs and behaviors which particularly concern parents and community leaders
- Conduct visibility operations and pay attention particularly to motorcycles for speeding, cyclists not sharing the road in a safe manner and persons practicing « roller skiing » in the sectors of Redmond Road, 5th Avenue and Boulevard Valcartier.
- 3. Conduct increased visibility operations on Boulevard Valcartier, especially during the height of tourist season at *Village Vacances Valcartier*.
- 4. Maintain and reinforce good relations between the *Sûreté du Québec* and the citizens and their representatives.
- 5. Reinforce the application of By-laws concerning parking on public roads, particularly during the winter season.
- 6. Surveillance of school zones (30 km/h).
- 7. Increase surveillance of ATVs and motorbikes in certain sectors (sand pits and private properties).
- 8. Increased surveillance of cyclists' good practises on public roadways.

"Film set décor" conditional use:

The "film set décor" conditional use on lots 2 196 997, 2 197 002, 3 358 692 and 6 105 365 (Barkskins) ends on June 3rd, 2020. If the conditional use is not renewed before this date, the site will have to be dismantled and put back to its initial state.

Urbanism by-laws consistency with the MRC de la Jacques-Cartier's revised Master Development Plan:

Urbanism by-laws are being revised to be consistent with the Master Development Plan revised by the MRC de la Jacques-Cartier. These new by-laws will be adopted this fall 2020.

11.3 Minor derogation – lot 2 196 747

This minor derogation consists in authorizing the derogatory nature of a detached garage which is already built at 3.78 meters from the lot's front line instead of the regulatory 6 meters.

12.2 Awarding of contract for the construction of an outdoor skating rink – Phase 1

WHEREAS the Municipality called a public tender on November 27th, 2019, to award a contract for the construction of an outdoor skating rink;

WHEREAS the bids were opened on December 12th, 2019 in the presence of Mayor Brent Montgomery, Joan Sheehan, Director General, Heidi Lafrance, Assistant Director General, Dany Laberge, Public Works Department foreman, Jean-Thomas Marois-Fiset, engineer for WSP and certain company representatives having submitted a bid;

WHEREAS 4 contractors submitted bids and the results are as follows;

Parko inc.	935,828.00
Bé-Con Construction	994,998.91
Durand Construction	1,024 371.38
Deric Construction	1,069 838.72

WHEREAS following analysis of the bids by Mr. Jean-Thomas Marois-Fiset, engineer for WSP and following the advice of the Municipality's legal counsel, it appears that the lowest bid submitted, that of Parko inc., is inadmissible and non-conform to the specifications documents requirements since a portfolio was not attached, therefore the contract cannot be granted;

WHEREAS Bé-Con Construction inc. submitted the second lowest bid, which is substantially conforming to the specifications documents' requirements;

AND UNANIMOUSLY RESOLVED:

THAT the preamble is an integral part of this document;

TO reject the bid submitted by Parko inc. considering it is inadmissible and non-conforming to the specifications documents' requirements;

TO grant the contract for the construction of an outdoor skating rink to Bé-Con Construction inc. in the amount of \$994,998.91 excluding taxes, following the bid submitted and dated December 12th, 2019.

TO authorize the Mayor and Director General to sign, in the name of the Municipality, all documents required following the present resolution.

2.3 Municipal skating rink phase 2 (roof) – professional services

WHEREAS the municipal skating rink will be relocated and reconstructed during the summer of 2020;

WHEREAS Phase 2 of the project consists in building a roof over the new skating rink in 2021;

WHEREAS the engineering firm WSP Canada inc. has prepared specifications documents for Phase 1 of the project;

WHEREAS it is planned to call for bids for the construction of a roof during the fall 2020 and building in 2021;

SECONDED BY Councillor Dorothy Noël

AND UNANIMOUSLY RESOLVED:

TO mandate the engineering firm WSP Canada inc. to prepare the specifications documents for the building of a roof over the new municipal skating rink in according to the design submitted by BBC Architectes, and this, at the cost of \$50,300 excluding taxes. This price includes a part of the surveillance costs.
