GENERAL CORRESPONDENCE AND FOLLOW-UP OF PREVIOUS MEETINGS

Correspondence from the Ministry of Transport concerning the school zone in front of Valcartier Elementary (1748 Boulevard Valcartier):

The Ministry of Transport responded to Resolution No. 030320 requesting an analysis be conducted to improve the traffic in the school zone in front of Valcartier Elementary school on August 17th, 2020. In this regard, the MTQ is favourable to extending the school zone to a length of up to 120 metres. Moreover, in order to ensure the safety of the pedestrian crossing, rectangular flashing lights will be installed, which will increase visibility notably in the presence of pedestrians.

WHEREAS four companies submitted bids which were opened publicly on September 9th, 2020 at 11:05 am:

WHEREAS the bid from Jan-Pro was deemed non-conforming given the price of the bid was based on a yearly rate and not hourly, this bid was rejected;

WHEREAS confinement at home and the unfamiliar times all Quebecers and the world are going through, remind us more than ever that decent housing is too often taken for granted;

WHEREAS 305 590 households in Québec need adequate and affordable housing;

WHEREAS these needs are not being met by the current housing offerings;

WHEREAS the revival of the Quebec economy definitely involves the construction of social and community housing;

WHEREAS the investments in community housing achieve a dual objective, namely to help the most vulnerable households while generating significant economic benefits;

WHEREAS each dollar invested in the realization of housing community housing projects generate \$ 2.30 in economic activity in the construction sector;

WHEREAS it is necessary to adequately house all Quebecers;

10.1 Report from the person responsible for Public Works – Mr. Dany Laberge

Mr. Dany Laberge submitted his report to the Director General before the meeting. Here is a summary:

Unforeseen repair works need to be carried out on the tractor and the 6-wheel dump truck in the coming weeks. These works were not budgeted, but have been authorized by council:

Creation of work group to study the speed limits on the roads of the Municipality:

The following committee is formed:

Creation of a work group to study the design of the municipal parks:

Mission: to find permanent solutions to different problems regarding municipal parks (Clark's Bridge and the 2 river accesses via Redmond Road), more precisely safety and parking.

Link between rue Caroline and the Lac Roland sector by lot 3 985 968 belonging to the Municipality:

Residents from rue Caroline and the Lac Roland sector have asked the Municipality to create a pedestrian link between the two neighborhoods via lot 3 985 968 so that children may cross from one sector to the other safely without taking 5th Avenue.

After discussing this, the members of council would like to get the opinion of the residents in these sectors. A survey will be carried out in order to evaluate their interest and make a decision on this matter.

10.2 Awarding of contract for the winter maintenance of water reservoirs, municipal parks and turning points

WHEREAS a call for bids by invitation was sent on August 10th, 2020 to Déneigement Clay Boyd, Transport LMA Lapointe, Transport Ronald Murphy enr., Excavation Yves Bergeron enr. and Transport Eric Monaghan inc. For the winter maintenance of water reservoirs, municipal parks and turning points;

- Reservoir zone- Redmond Road (Redmond bridge sector);
- Reservoir 5th Avenue sector (between civic numbers 87-90, 5th Avenue);
- Municipal park (Clark's bridge sector);
- Municipal park (Sommet Bleu private sector);
- Route 371 turning point (Stoneham-et-Tewkesbury limits)

WHEREAS one contractor submitted a bid and it was opened on September 3rd, 2020 at 11:05 am.

To award a three (3) year contract to Déneigement Clay Boyd (2633-5133 Québec inc.) for the winter maintenance of water reservoirs, municipal parks and roundabouts for the 2020-2021, 2021-2022 and 2022-2023 winter seasons, and this, in the amount \$10,200 excluding taxes. The Mayor and Director General are duly authorized to sign the contract in the name of the Municipality.

10.3 Awarding of contract for the winter maintenance of municipal parking lots

WHEREAS the winter maintenance of the Community Centre parking lot will be different this year due to the repositioning of the skating rink and the enlargement of the parking lot;

WHEREAS an estimate for the winter maintenance of municipal parking lots (City Hall and Community Centre, municipal garage and fire hall, multifunction complex and United Church – gym and Fire Department) was requested from the contractor carrying out this maintenance for the past three winter seasons, Excavation Yves Bergeron enr.;

WHEREAS Excavation Yves Bergeron enr. was the only bidder at the last call for bids for the said contract in 2017;

AND UNANIMOUSLY RESOLVED:

To award a one-year contract to Excavation Yves Bergeron enr. for the winter maintenance of municipal parking lots for the 2020-2021 winter season, and this, for the amount \$11,830.00 excluding taxes. In the event that the snow must be removed, this service is not included in the contract. The Mayor and Director-General are duly authorized to sign the contract in the name of the Municipality.

11.2 Report from the Municipal Inspector

Mr. Stacy Gagné gives a verbal report of the Urbanism Department's activities. Here is a brief summary :

Correction of a shared drainage ditch (lots 4 105 379 and 4 105 382) in the Domaine des Plateaux:

WHEREAS a water drainage and right of way exists on lot 4 105 382 in favor of lot 4 105 379 property of the Municipality under number 16 051 918;

WHEREAS this ditch had been badly positioned;

WHEREAS the ditch, once moved, will improve the efficiency of maintenance by our Public Works team;

WHEREAS the ditch will be safer with a reduced slope;

WHEREAS the design of the ditch will ensure its sustainability.

AND UNANIMOUSLY RESOLVED:

THAT the Municipality mandate and pay the professional fees for engineering and survey services to assure quality work;

THAT the ditch be installed according to the water drainage servitude;

THAT the owner of lot 4 105 382 pay for the installation costs as well as the material necessary for the works to be carried out on his property, and this, according to guidelines provided by the professionals mandated by the Municipality.

11.3 Minor derogation request – lot 6 341 416

This minor derogation request has been cancelled since it no longer meets the criteria for a derogation request.

11.4 Fall 2020 treatment - Biological control of biting insects

WHEREAS the firm Conseillers forestiers Roy submitted an offer of services to carry out the biological control of biting insects in order to reduce the larval density in main waterways before the spring melt, and this, for the price and sum of \$6,000.00 excluding taxes.;

WHEREAS the members of council are of the opinion that this service is necessary to control biting insects;

IT IS PROPOSED BY Councillor Dorothy Noël

SECONDED BY Councillor Thomas Lavallee

AND UNANIMOUSLY RESOLVED:

To mandate the firm Conseillers forestiers Roy to carry out a fall treatment of waterways, and this, for the price and sum of \$6,000.00 plus applicable taxes.

Councillor Maureen Bédard is opposed to this treatment, she is rather in favor of letting nature run its course. She asks elected officials to take into consideration the most recent studies on bti and to learn about new techniques for controlling biting insects.

12. RECREATION, CULTURE AND COMMUNITY LIFE

12.1 Report from the Sports and Recreation Director – Mrs. Pamala Laberge

Mrs. Laberge submitted her report to the Director General before this meeting. Here is a summary:

Fall sports and leisure activities are gradually resuming according to Public Health guidelines.

2020 summer Playground Program:

Given the challenges and guidelines imposed by COVID-19, the 25% price reduction, the absence of bus transportation and the reduced cost of special activities, the additional deficit for the 2020 summer Playground program is of \$1,800.00.
