### 3. ADOPTION OF MINUTES

Dossier 422872 – Request to the Commission de protection du territoire agricole for exclusion of part of lots 2 196 882 and 4 396 680 for the development of Phase 4 of the Domaine Saint-Gabriel as well as part of lot 3 693 496 for the development of Phase 3 for the Villas Saint-Gabriel project included inside the protected agricultural zone:

On October 22, 2020, the Municipality participated in public meeting with the *Commission de protection du territoire agricole* concerning dossier 422872 via the Zoom platform. During this meeting, the Municipality informs the Commission of the withdrawal of which is a part of lot 3 693 496 (Villas St-Gabriel – rue Morley). On November 11, 2020, the Commission gave its decision and rejected the request for exclusion by virtue of Article 65.1 of the *Loi sur la protection du territoire agricole*.

# Permission to use a parcel of land from the National Defence for the extension of the municipal walking path (2 196 107-2 and 3 086 041-2):

In a correspondence dated May 15, 2019, the Municipality asked the Ministry of National Defence for permission to use a parcel of land to extend the municipal walking path to reach Boulevard Valcartier near the gatehouse at the Valcartier base. In a letter dated November 19, 2020, the Ministry of National Defence informs the Municipality that it is not able to grant this request. In summary, the reasons for the refusal are particularly to maintain a buffer zone absorbing noise and dust. Moreover, considering the dangerous nature inherent to the activities of the Canadian armed forces, it is not advisable to reduce the buffer zone to guarantee the safety of the neighbouring population.

# 6. NOTICES OF MOTION AND BY-LAWS

# 6.1 Public Consultation meeting concerning Draft By-law no 237 modifying the Zoning By-law no 148

A public assembly meeting concerning draft By-law No. 237 preceded the regular session of council at 7:15 pm. It was held by videoconference and will be available on the municipal website as of Tuesday, December 8, 2020.

Are present:

The Mayor and six municipal councillors; the Director-General.

The Mayor Brent Montgomery invited the Director-General, Mrs. Heidi Lafrance, to present draft By-Law No. 237.

In accordance with the provisions of Article 145.33 of the LAU, a public meeting is held to present the nature of the project and give the right to any interested person to be heard. To guarantee the right of anyone interested to be heard in the context of the pandemic, the public meeting is accompanied by a written consultation. A detailed presentation of the project was available on the Municipality's website and comments could be received by email until the adjournment of the meeting. No comments or questions were received.

The purpose of the by-law: To add the following note 2 to C-2 usage class: Only code 6519 (Other medical and health service) is authorized in this zone specifically authorizing assisted dying homes; and add class C-8 Rural accommodation to P-3 zoning.

This draft by-law contains provisions which may be the subject of a request from persons interested in the target area and the areas adjacent to it, so that a by-law containing these provisions is submitted for their approval in accordance with to the *Act respecting elections and referendums in municipalities*.

Such a request is intended to submit these provisions for the approval of qualified voters in the zone to which they apply and those of any contiguous zone from which a valid request originates.

A provision which applies to more than one zone shall be deemed to constitute a separate provision which applies particularly to each zone mentioned.

To be valid, any request should:

- Clearly indicate the provision that is the subject and the area from which it comes; and if applicable, mention the area for which the request is made;
- Be signed by at least 12 persons interested in the area that it comes from or by the majority in the case where fewer than 21 persons interested in the area that it comes from;
- Be received at the municipal office, at 2215 Boulevard Valcartier, Saint-Gabriel-de-Valcartier, at the latest on January 8, 2021, at 4:30 pm. A public notice to this effect will be posted on December 21, 2020.

Information making it possible to determine which persons interested are entitled to sign an application can be obtained at the municipal office during normal office hours. A copy of the said second draft by-law may also be obtained, free of charge, by any person who requests it.

All the provisions of a second draft which will not have been the subject of a valid request may be included in a by-law which will not have to be approved by qualified voters.

After a presentation of the draft by-law, no questions or comments were put forward.

# 6.2 Adoption of second Draft By-law No. 237 modifying the Zoning By-law No. 148 to add a note to the usage class C-2 and to add the usage class C-8 to the P-3 zoning.

WHEREAS a Notice of Motion for this By-Law was given at a previous session of council held on October 5, 2020;

WHEREAS a first draft By-Law No. 237 modifying zoning By-Law No. 148 in order to add a note to use class C-2 and to add a usage class C-8 to zoning P-3 was adopted unanimously at the regular Council meeting held on November 2, 2020;

WHEREAS a public consultation meeting to present the draft By-Law No. 237 was held on December 7, 2020, at 7:15 pm in accordance with the *Land Use Planning and Development Law*;

WHEREAS a copy of the second draft By-Law No. 237 was submitted to council members at least 72 hours prior to the adoption of the said by-law and that all members present declare having read it;

WHEREAS the Secretary-Treasurer mentions the object of this by-Law and its scope, during this meeting: Adding to the C-2 usage class and C-8 usage class the following note 2: Only the code 6519 (other medical or health services) is authorized in this zone specifically authorizing assisted dying housing facilities; and add Class C-8 Country-style accommodation to P-3 zoning.

WHEREAS copies of the by-law were made available to the public for consultation as of the beginning of the meeting;

WHEREAS the Municipality wishes to enter into an intermunicipal agreement with the Ville de Québec in order to bring the waste to their incinerator and, as of the beginning of service equipment for food waste treatment at the Municipal Biomethanization Center, the food waste;

This 10-year agreement will take effect on January 1, 2021.

# 12.1 Report from the Sports and Recreation Director – Mrs. Pamala Laberge

Mrs. Laberge submitted her report to the Director General before this meeting. Here is a summary:

#### **Community activities for Christmas:**

Advent calendar – December 13: Car rally and visit with Santa at the Community Centre

There will be a distribution of surprises for the elders of the Municipality with the name of the various resources available (meals, accompaniment, friendship visit, etc.)

Throughout the month of December: animated municipal walking path and Christmas educational videos with the elf Étincelle (science, arts and animated stories)

December 21-22: Preparation and distribution of Christmas hampers

# Sports and recreation activities:

No activity has resumed its course and no programming is made for January 2021. We are still awaiting directives from the Ministry of Public Health.

# Municipal skating rink:

The ice rink is scheduled to open as soon as the weather permits, according to guidelines issued by Public Health. Due to the pandemic and to maximize the capacity to use the ice surfaces and allow as many citizens as possible to enjoy them, only free skating will be authorized for an indefinite period (hockey sticks and pucks prohibited).

Rink: maximum of 25 persons

Skating path: maximum 25 persons

TO BE NOTED: Users must respect directives from on-site security personnel at all times following developing recommendations from Public Health.

# 12.2. Municipal skating rink project phase 2 – public call for tenders

WHEREAS construction of phase 1 of the skating rink has been completed;

WHEREAS the will of elected officials is to build phase 2 in 2021 to take advantage of this new multifunctional space as quickly as possible;

WHEREAS BBC Architects and WSP Engineers worked together to produce the plans and specifications for the construction of phase 2, i.e. the construction of a roof to cover the ice rink;

### AND UNANIMOUSLY RESOLVED:

TO launch a public call for tenders on the Electronic Tendering System (SEAO) in December 2020 for the construction of phase 2 of the municipal outdoor skating rink (the roof) in spring 2021. The opening of tenders should be done at the beginning of 2021.

The Mayor, Brent Montgomery informed the members of Council that the last session of the MRC Council of Mayors was held on November 25, 2020.

# **Budget MRC:**

The MRC Council of Mayors adopted a budget of \$2,620,480 for the 2021 fiscal year. This compares to a budget envelope of \$2,598,477 for the year 2020.

The share of costs for Saint-Gabriel-de-Valcartier amounts to 11.94% for 2021 compared to 12.06% for the year 2020. This calculation is based on the property value of the Municipality.
