*Eco-Centre:* landscaping has begun, gate and fences have been ordered, partners have been contacted for collection of materials, soil testing, signage in preparation. The goal is to open for the beginning of May.

#### 11.3 Minor Derogation – Lot 5 283 355

This minor derogation request consists of confirming the issuance of a subdivision permit for a lot in three irregularly shaped sections where two of the lots are found to be non-conforming with respect to the frontage.

WHEREAS the requesting party would have had the adequate metres of frontage on the street if she hadn't sold to a third party a few months before;

WHEREAS the third cottage is not legal, since a permit for a barn was issued for this building, not for a residence;

WHEREAS no septic installation permit request was received for the third building;

WHEREAS there is only one well on the property to supply these three buildings;

WHEREAS 38 feet of frontage is missing for two of the three lots;

WHEREAS the lots were subdivided before the year 2000 and were merged without the request of a permit with the Municipality;

To refuse the minor derogation request for lot 5 283 355 of the official Saint-Gabriel-de-Valcartier cadastre for the division of a lot into three distinct parts, and this, according to the recommendation of the UCC.

#### 11.4 Minor Derogation – Lot 6 351 051

This minor derogation request consists in confirming the issuance of a building permit for a residence with a 90-degree angle to the street when the municipal by-law allows for a 30-degree angle maximum.

WHEREAS the future residence will be located at over 100 metres from the street in the mountain;

WHEREAS the closest neighbour is situated 100 metres from the future construction;

WHEREAS the septic installation, as well as the garage will respect municipal and provincial by-laws;

WHEREAS the future residence will not be visible from the 5<sup>th</sup> Avenue;

WHEREAS the reason for the inclination of this home is to be able to benefit from solar power to its full potential;
