Considering the Clerk-Treasurer mentions the purpose of the said draft by-law and its scope, during the meeting: The purpose of the amendment is to add a new element concerning any gift, hospitality or other benefits. This code of ethics and good conduct contains the values of the Municipality in matters of ethics and imposes on the employees various obligations notably in matters of conflicts of interest, receipt of various advantages, discretion and confidentiality, use of the resource of the Municipality, respect of persons, loyalty to the Municipality and sobriety at work;

11.2 Report from the Municipal Inspector – Mr. Stacy Gagné

Mr. Gagné gave a verbal report on the activities of the Urbanism Department.

11.3 Minor Derogation - Lots 6 460 505 and 6 460 506

This Minor Derogation consists of confirming the issuance of a building and subdivision permit for a property divided into three distinct lots, one of which has a width of 23.9 meters and allows access to 4 adjoining lots by a single access whereas the municipal by-law requires a minimum lot width of 50 meters and a rectangular shape and the construction of one access per property.

WHEREAS the zoning by-law stipulates that each property must have its own access on its own property and that there is a possibility of creating an entrance for each lot with the 500 meters of frontage present on the totality of the two lots;

WHEREAS the impact on the neighbors living on Rourke Road will be too important because of the road and the construction in the backyard;

WHEREAS the minor exemption is not considered minor, but major because of the width of lot number one where more than 50% of the regulatory width is missing;

WHEREAS the municipality's goal is to avoid private roads, which serve several properties;

WHEREAS the configuration of the lots is not in conformity with the urbanism norms;

AND UNANIMOUSLY RESOLVED:

TO turn down the request for minor exemption for Lots 6 460 505 and 6 460 506 of the official cadastre of Saint-Gabriel-de-Valcartier, and this, according to the recommendation of the UCC.

11.4 Decision – Residential development projects under the Opening and Extension of Streets Policy

With the framework of the Policy concerning the Opening and Extension of Streets, two residential development projects were submitted at the meeting of November 15th, 2021:
