# 11.3 Authorization to apply the provincial regulations adopted by virtue of the Environment Quality Act, the application of which is the responsibility of the Municipality

WHEREAS the Municipality is responsible for the enforcement of certain regulations made under the Environment Quality Act, including the Regulation Respecting Wastewater Disposal Systems for Isolated Dwellings (R.L.Q. chapter-2, r. 22)

WHEREAS pursuant to section 115.47, the Municipality may institute penal proceedings for a violation of a provision of a by-law made under the Environment Quality Act and the enforcement of which is the responsibility of the Municipality

WHEREAS pursuant to section 119.0.2 of the Environment Quality Act, when the Municipality is required to enforce all or part of a by-law made under the Environment Quality Act, the officers, or employees of the Municipality, duly authorized by the Municipality, are vested with the powers of inspection provided for in section 119 of the Act

WHEREAS it is necessary to designate the official responsible for the application of the provisions of the by-laws made under the Environment Quality Act, the application of which is the responsibility of the Municipality, to authorize this official to issue statements of offence in the event of a contravention of these provisions and to authorize him/her, in accordance with the section 119.0.2 of the Environment Quality Act, to benefit from the powers provided for in section 119 of the same Act

WHEREAS the Municipality is also responsible for the application of the By-law respecting the Safety of Residential Swimming Pools (R.L.R.Q., chapter S-3.1.02, r. 1), and this, by virtue of section 2 of the Act respecting the Safety of Residential Swimming Pools (R.L.R.Q., chapter S-3 1.02), and that it is therefore necessary to designate the official responsible for the application of this by-law and to authorize him to issue statements of offence in the event of a contravention of the provisions of this by-law

WHEREAS it is also necessary to designate the official responsible for the application of any other provision of a provincial by-law whose application is the responsibility of the Municipality

### AND UNANIMOUSLY RESOLVED:

THAT the Municipal Inspector be charged with the enforcement of the provisions of the by-law made under the Environment Quality Act and whose application is the responsibility of the Municipality

THAT the Municipal Inspector be authorized to institute penal proceedings by issuing a statement of offence in the event of a contravention of a provision of a by-law made under the Environment Quality Act and whose application is the responsibility of the

# Municipality

THAT the Municipal Inspector be duly authorized, pursuant to section 119.0.2 of the Environment Quality Act, and consequently be vested with the powers provided for in section 119 of the Environment Quality Act for the purposes of enforcing the by-laws made under that Act, the application of which is the responsibility of the Municipality

THAT the Municipal Inspector be charged with the enforcement of the provisions of the By-law respecting the Safety of Residential Swimming Pools (R.L.R.Q., chapter S-3. 1.02 r. 1), and that he be authorized to institute any penal proceedings by issuing a statement of offence in the event of a contravention of a provision of this by-law

THAT the Municipal Inspector be responsible for the application of any provincial bylaw whose application is under the jurisdiction of the Municipality, and that he be authorized to institute penal proceedings by issuing a statement of offence in the event of a contravention of a provision of such by-law.
