5. GENERAL CORRESPONDENCE AND FOLLOW-UP OF PREVIOUS MEETINGS

Median proportion and comparative factor of the property assessment roll for fiscal year 2024:

In accordance with the provisions of the Act respecting municipal taxation (RLRQ, chapter F-2.1 art. 264), the Minister of Municipal Affairs and Housing has approved assessment roll for fiscal year 2024. The approved results are as follows:

Median proportion: 77% Comparative factor: 1.30

The median proportion is an indicator of the general level of values recorded on the property assessment roll. It is determined by the median of a distribution of individual proportions relating the sale price of the properties involved in the transactions to their valuation.

The comparative factor, which is the inverse of the median proportion, is used to standardize the values entered on the roll, in particular for calculating duties on real estate transfers or for determining the quotas to be paid by municipalities to supramunipal organizations.

7.1 Authorization – Notice of Subjecting Immovables to the Exercise of a Pre-emption Right by the Municipality

WHEREAS the Municipality may, by virtue of articles 1104.1.1 to 1104.1.7 of the Municipal Code (RLRQ c. C-27.1), exercise a right of first refusal on any immovable it wishes to acquire for municipal purposes, with the exception of an immovable that is the property of a public organisms and the protection of personal information (RLRQ c. A-2.1);

WHEREAS the adoption of By-law No. 259 on the exercise of the Pre-emptive Right aimed at identifying the Territory Subject to the Pre-emptive Right and the Municipal Purposes for which Immovables may be Acquired;

WHEREAS this right can only be exercised following the registration of a Notice of Subjection to the Pre-emption refusal in the land register;

9.2 Financial Assistant Program for the training of Volunteer or Part-time

WHEREAS the By-law respecting the conditions of employment in a Municipal Fire Department sets out training requirements for firefighters in fire department to ensure a minimum professional qualification;

WHEREAS this By-law is part of a desire to guarantee municipalities the training of firefighters teams with the skills and abilities required to respond effectively in emergency situations;

WHEREAS in December 2014, the Quebec government established the Financial

Assistance Program for the training of volunteer or part-time firefighters and it has been renewed in 2024;

WHEREAS the main purpose of this program is to provide municipal organizations with financial assistance to enable them to have a sufficient number of qualified firefighters to act effectively and safely in emergency situations;

WHEREAS this program is also intended to promote the acquisition of skills and abilities required by volunteer or part-time firefighters working in a Municipal Fire Department;

WHEREAS the Municipality of Saint-Gabriel-de-Valcartier wishes to benefit from the financial assistance offered by this program;

WHEREAS the Municipality of Saint-Gabriel-de-Valcartier plans to train seven (7) firefighters for the Firefighters I program over the next year to respond effectively and safely to emergency situations on its territory;

WHEREAS the Municipality must forward its request to the Ministère de la sécurité publique through the MRC de La Jacques-Cartier, in accordance with article 6 of the Program;
