Residential pool inspections « Municipal inspectors will visit your properties and any corrections that are needed will be sent to you by mail. Citizens will have until July 1, 2025 to make any necessary modifications. » Our winter season is coming to an end and looking back we can safely say it was it was a relatively mild one. In fact, it has been ten consecutive months of mildest temperatures on record in Canada. There is an obvious trend here of climate change and we should act accordingly for the future. A good example of this is our skating rink with the roof and artificial ice which greatly extends the usable season.

THE INDISPENSABLE

In April we met with representatives of Hydro Québec concerning works to be carried out this summer regarding the removal of trees and branches near electrical power lines. They have identified problematic areas on our territory which could provoke power outages in inclement weather. I am sure that people do not want a repeat of the December 2022 catastrophe. So please consult the article in this bulletin for further information.

Starting during the month of May, the Provincial Government is requiring all municipalities to inspect all swimming pools to make sure they conform to new provincial safety regulations. Municipal inspectors will visit your properties and any corrections that are needed will be sent to you by mail. Citizens will have until July 1, 2025 to make any necessary modifications. We are asking for your collaboration during this process which is meant to save lives.

Other upcoming events include the return of The Flowered House Contest for a second edition and the garage sale, which includes distribution of small trees, will take place on May 26. Finally, our first market of the season, The Young Entrepreneurs Market, will be held on June 1.

SPECIAL COLLECTION FOR FALLEN LEAVES

Bags of leaves are not accepted during weekly household garbage collection.

There will be a special collection the <u>week of April 29.</u>

Bags of leaves must be placed by the side of the road in front of your residence.

MUNICPAL TAXES

This is a reminder that the second instalment of the municipal tax bill is due on July 1, 2024. The privilege of paying in three instalments can only be granted if all instalments are paid when due. Any payments received late will bear interest and penalties on the entire account.



FOOD WASTE COLLECTION

Distribution of the containers and bags is now finished on our territory! Nearly 1,250 starter kits have been delivered free of charge door-to-door to residents of Saint-Gabriel-de-Valcartier. If you haven't received your starter kit, please contact the Municipality to request one.

THE CONTAINERS AND PURPLE BAGS

Kitchen containers and bags for sorting food waste are provided free of charge. Every household in the Municipality has received at its door :

• a kitchen container for food waste collection;

- an initial six-month supply of purple bags;
- A collection guide to help you get started.

Thereafter, new purple bags will be available at 4 locations: City Hall, the municipal library, the Valcartier Community Centre and the Physik Centre. For more information, visit the « Collecte sélective » on the municipal website.

Municipalité de Saint-Gabriel-de-Valcartier Hydro-Québec dégage les fils près des arbres dans votre secteur



Bon an mal an, plus de 40 % des pannes d'électricité sont causées par la chute de branches ou d'arbres sur des lignes de distribution. Lors d'événements météorologiques majeurs dans des secteurs boisés, cette proportion peut s'élever jusqu'à 70 %.

C'est en partie pour réduire le nombre de ces pannes qu'Hydro-Québec dégage les fils moyenne tension des arbres et des branches qui s'en approchent trop.

Chaque année, selon la main-d'oeuvre disponible, on veille à dégager environ 17 000 km de lignes en priorisant les municipalités où la situation est la plus critique, selon un cycle de cinq ou six ans.

INVASIVE EXOTIC PLANTS

An invasive alien plant is a plant species that has been introduced outside its natural range, either intentionally or unintentionally. Often used for horticultural purposes, these plants spread rapidly to new sites, forming colonies that can quickly become dominant. As well as being a threat to the environment, these plants can also pose a threat to the economy or society.

In recent years, we have observed the rapid spread of these plants across our territory, and we have taken note of several concerns expressed by citizens regarding their presence. From July to September, an inventory of invasive exotic plants will be carried out throughout the Municipality.

The inventory will be carried out by a team from the *Corporation du bassin de la Jacques-Cartier*. The team, clearly identified by sweaters bearing the CBJC logo, will be touring the streets of the Municipality, as well as the wetlands and waterways previously identified as relevant to the inventory. The aim of this project is to determine the current status of invasive exotic plants on our territory, and to obtain an overview of the situation. The Municipality will then be better equipped to know where the most worrisome colonies are located, and to intervene according to the situation.

Note to landowners with a wetland or watercourse on their property. These may have been targeted by the inventory. It will be important to let the team members carry out their work so that the inventory is as accurate as possible. If you have any questions about this project, please contact the Environment and Urban Planning Department.

URBAN CHICKEN COOPS

To all hen owners

From now on, anyone owning laying hens on municipal territory must register on the Gestipattes platform available via our website. Registration is free and must be completed within 15 days of acquiring the hens. The hens will then be registered for the period from January 1 to December 31 of each year, and the registration will have to be renewed the following year if you keep your hens for the winter period, or if you purchase new hens.

Rules and regulations

Only one Chicken coop is permitted per lot, and it must comply in all

respects with regulations.

A maximum of 6 hens is authorized for lots smaller than 2,000 m². For lots larger than 2,000 m², a maximum of 12 hens is authorized.

Roosters are not permitted.

REMINDER FOR RESIDENTIAL POOL OWNERS

Residential swimming pools represent a major risk of drowning for young children, particularly when they are not under adult supervision and the installations are not adequately secured.

In response to a recommendation made by several coroners in recent years, provincial regulations have been amended and will now apply to all pools, regardless of when they were installed.

The purpose of the Residential Swimming Pool Safety By-law is essentially to control access by young children to residential swimming pools through simple measures. The by-law has been delegated to the municipalities, which are responsible for enforcing it.

The municipality of Saint-Gabriel-de-Valcartier will therefore be inspecting all swimming pools on its territory, starting next spring. The municipal inspector will visit your property, check your pool and mail you a list of corrective measures required to comply with provincial regulations. **The deadline for compliance is July 1, 2025.**

NEW TREE FELLING REGULATIONS IN EFFECT

It will now be forbidden to cut down, damage, top or destroy any tree located in the front yard and with a diameter of 10 centimetres or more measured at 1.3 metres above the natural ground on public or private property, if it does not comply with any of the following conditions:

- 1. The tree must be dead or suffering from an incurable disease;
- 2. The tree must be dangerous to human safety;
- The tree must be a nuisance to the growth and well-being of neighbouring trees;
- 4. The tree must cause damage to public or private property;
- 5. The tree must necessarily be felled as part of a public works project;
- 6. The tree must necessarily be felled for a construction or landscaping project authorized by the municipality.

It is the landowner's responsibility to contact the Municipality before felling the tree, in order to justify the reason and also to prove that at least one of the conditions listed above has been met.

In addition, a lot containing a main building must have a minimum of 1 tree in the front yard for every 15 linear meters of lot width.

Each lot must retain 1 tree per 375 m² of lot area at all times, with the exception of lots located in the sector where Interim Control Bylaw RCI 2019-91 applies, where the standard is 1 tree per 250 m².

The Interim Control By-law is a by-law drawn up by the Communauté métropolitaine de Québec to limit interventions in the watershed of the Québec City water intake in the Saint-Charles River. As a result, any work or construction carried out on a property located in this area is subject to stricter rules than elsewhere on the territory.



As of <u>April 30</u>, all shelters considered as temporary, such as garages

(mobile wood panels or canvas) and snow fences, must be dismantled. According to the established bylaw, these



structures are authorized from October 1 to April 30.

Please respect your neighborhood and comply

with this regulation under penalty of law.

(\$200 minimum per day for a continuing offense).

BIOLOGICAL CONTROL OF BITING INSECTS

The Municipality will resume biological control of biting insects in the summer of 2023 with the firm Conseillers forestiers Roy (CFR).

Control of biting insects

Definition: Program whose objective is to control the nuisance caused by **black flies** and **mosquitoes** by using no chemical pesticides.

CFR controls biting insects using a **selective biological larvicide**, BTI. Treatments are carried out on larval breeding sites in the water environment by hand and ground. The area targeted for treatment generally covers several square kilometers depending on the characteristics of the site to be protected and the environmental conditions.

What species are treated?

Only small black flies and mosquitoes are treated for

biological control of biting insects. <u>Ticks, fireflies,</u> <u>houseflies and horseflies are not affected by the</u> <u>treatment.</u>

The biting insect control program is seeking the cooperation of citizens to allow access to areas of high production of mosquitoes and black flies for application crews.

TREATMENT TO ERADICATE AMBROSIA

The Municipality will participate in a treatment program to eradicate ragweed. The common goal is to **permanently**

eliminate this highly allergenic plant. We therefore count on the participation of the entire community in order to reach our

goal to permanently eliminate ragweed.

Here's how you can actively participate:

- 1. Uproot any ragweed plants on your property.
- 2. Locate the infested zones in your neighbourhood.
- 3. Make your neighbours aware of the hazards posed by this plant.

This annual collective **program** aims to **significantly reduce** pollen levels and this, in the best interest of the local population.

The socioeconomic impact related to respiratory allergies amounts to 250 million dollars annually.

On May 26 from 10:00 am to 2:00 pm, the Sports and Recreation Department will be holding a community yard sale. You have the opportunity to rent a table or tables during the sale. A total of 22 tables will be available on the covered municipal rink. *You can register on the Voilà! platform of the Municipality's website.* You will have the option of paying online or coming to City Hall to pay. However, if your table is not paid for on the day of the sale, your registration will be cancelled. The price is set at <u>\$10 per table</u> and tables are reserved for residents 18 years of age and older. Reserve early! The event will take place rain or shine. Please note that the Public Works Department will have tools and small equipment for sale or donation; first come, first served!

Also, in May, as part of Tree and Forest Month, the *Ministère des Forêts, de la Faune et des Parcs* is organizing activities in collaboration with the Association forestière des deux rives (AF2R). For the occasion, we are planning to distribute free tree sapplings in order to raise the population's awareness of the importance of and respect for the tree and the forest. PUBLIC WORKS

HOW TO DISPOSE OF YOUR HAZARDOUS HOUSEHOLD WASTE (HHW)?

These dangerous materials must be brought to the depot location at the municipal Eco-Centre (2329 Boulevard Valcartier).

Here is a list of materials that can be recuperated:

PAINTS

Sold by retail businesses (100 ml containers and larger); sold by wholesale businesses (170 L containers and larger intended for architectural use); primers and paints (latex, alkyd, enamel and other); metal or anti-rust paint, stain; aluminum paint; dyes; varnishes; lacquers; products or preparations for the treatment of wood (preservatives) or masonry (acrylic sealers for driveways); signalisation paints (those available in retail businesses); Aerosol paints.

ORGANIC HAZARDOUS HOUSEHOLD WASTE

Acetone, adhesives, aerosols, solid fire starter, rubbing alcohol, starter fluid, glue, wax, antifreeze, caulking, dye, plastic cement, solid fuel, fondue fuel, lock de-icer, degreasing agents, oil stain remover, paint thinner, petroleum distillate, ink, epoxy, gasoline, ethylene glycol, roofing tar, motor grease, heating and lamp oil, lubricant, methanol, petroleum, polish, Polyfilla, leather, suede or vinyl protector, liquid resin, silicone sealant, wallpaper remover, shoe dye, turpentine, toluene.

INORGANIC HAZARDOUS HOUSEHOLD WASTE

Acids, bases, oxidizing agents, batteries, pesticides and insecticides

Fluorescent compact light bulbs (CFL)

If you are not sure if a product that you would like to dispose of is on the list, bring it with you and the trained employees will help you.

Each container must be intended for residential use only. All products must be in their original containers. For safety reasons, do not mix products. You may also bring in your used oil, used oil filters and oil containers (non commercial use only). This service is also offered free of charge throughout the year by the Municipality during bulk waste pickup upon reservation of the service.

BULK GARBAGE COLLECTION (BULK WASTE)

The Municipality collects bulk waste on a weekly basis. Please do not deposit non-household waste in front of large refuse containers or community mailboxes. You must call **418 844-1218** to request this service with itemized list of materials to be collected or register on-line on the Municipality's Website, under the «On-line request» section.

Note that this service is offered a maximum of 4 times per year, per residence.

It is important that the materials to be collected be set out in an organized manner (ex: carpets must be rolled and tied, metal must be sorted, wire must be rolled and tied, etc.)

You may dispose of used tires (non-commercial use only) and rims. You can also dispose of used vegetable oil. Oil must be in its original container or in an identified clear plastic bottle.

Please note that vehicle carcasses or frames, tree and brush debris, household garbage and leaves as well as recyclable materials will not be collected during the weekly collections.

You may also dispose of these materials as well as renovation materials at the Saint-Gabriel-de-Valcartier Eco-Centre (2329 Boulevard Valcartier). You may not dispose of these in your household garbage bin as the waste management company will not pick up your garbage.

Thank you for your collaboration.

The Municipality asks for your collaboration in regards to garbage bins. Once your



garbage and recycling has been picked up, please remove them from the side of the road and return them to your house as soon as possible in order to avoid risks of theft. Thank you !

FIRE SAFETY SERVICES

Prevention Visits

The Municipality of Saint-Gabriel-de-Valcartier Fire Department wishes to inform the population that the Residential Fire Prevention Program will be back to its original format as of May 2024. Uniformed and identified firefighters from the Fire Department will be visiting the inside and outside of homes in our Municipality.

These firefighters are mandated by the Fire Safety Department to inspect smoke alarms and make recommendations should you have any questions about the safety of your home. All of this is in accordance with municipal **By-law No 213 concerning Fire Prevention**. The purpose of these visits is to prevent fire hazards in order to ensure the safety of all citizens in a spirit of cooperation. According to the risk coverage plan, each house must be visited every 6 years. Some higher-risk residential areas must be visited every 3 years. So if it's been a while since we've visited you, we'll be sure to stop by this summer! As part of their visits, firefighters will verify the installation and operation of smoke alarms. We remind you that a smoke alarm must be installed on each floor, including the basement. The best places to install them are in the hallways, near the bedrooms, making sure that there are no obstacles blocking the flow of smoke.

Whether battery-operated or electric, smoke alarms should be replaced every 10 years according to the instructions on the alarm unit. Building owners must provide their tenants with a smoke alarm, but it is the tenant's responsibility to change the battery. It should be noted that batteries must be replaced every 6 months. We suggest that this be done at each time change. If you have alarms to change this year, we recommend photoelectric models with built-in lithium batteries, which are good for 10 years.

Did you know that burning grass and vegetation in the spring can be very dangerous?

Every year, the fire department has to respond to fires of this type where the owner has lost control. The spread of this type of fire can be very rapid and insidious, especially when the wind is blowing. It is therefore strongly recommended not to use this type of method to clear your property. The best way to get rid of a large quantity of branches or vegetation is to take them to the ecocenter, not to burn them.

CIVIL SECURITY

In an emergency situation, you and your family must be prepared for the first 72 hours and cope without power or running water.

As it is with the entire population, it is your responsibility to have a **<u>72-hour emergency kit in your home</u>**. This kit will ensure your family's self-sufficiency during an evacuation or sheltering situation. Find out what to do in the event of a disaster. The Department of Public Safety offers a list of essential items to have in case of an emergency. This kit will help ensure your family's self-sufficiency during an evacuation or lockdown situation.

BACKYARD BIRDS BY MAUREEN BÉDARD, MUNICIPAL COUNCILLOR



COMMON STARLING

I couldn't wait to talk to you about this bird because it is my favorite bird to observe.

The common starling, also known as the European starling is a species of passerine bird in the Sturnidae family which has been introduced to all continents except Antarctica. It is present throughout Quebec and we get to see lots of them in our region. Although it is not native to Quebec, it has adapted very well over the many years.

This very noisy bird has glossy black plumage with iridescent metallic highlights and a black beak. It measures 19 to 23cm long and its size resembles that of the robin. During breeding season, from January to August, its bill is yellow and plumage has purple and greenish reflections. There is no difference between the two sexes, they are similar.

The common starling has two requirements to be present as a nester; it needs open environments for feeding on the ground as well as cavities for reproduction. It will nest in a cavity regardless of the height, either in the forest where it will occupy old woodpecker lodges on in town where this bird has adapted quite well to street lamps making its nest behind the light bulbs where it will also provide a pleasant atmosphere. The female will have 4 to 6 intense blue eggs without spots and most of the incubation will be done by the female. Incubation will last about 15 days and once the young leaves the nest around three weeks old, both parents will feed them for a few more days.

The main behavioral trait of the starling is its gregarious temperament which pushes it to form groups almost year-round which all feed together and spend the night together in order to protect the young and thus, form a large family.

The flight of the starling is very energetic, rapid and direct. The spectacular flights of this species are the group flights when we can see them evolving in the sky and forming clouds instantly changing direction.

This bird is an omnivorous species but the insectivorous diet in the broad sense predominates in all seasons. Berries and fruits such as strawberries and haskap can become very important in one's diet and are often the reason why we can see some mesh wrappings around such crops to protect the crops from these berry eating birds which can easily empty a field within a few hours.

The starling is a common species, often increasing in number and absolutely not threatened and therefore does not need any particular protection. You will learn a lot about this bird by observing its behavior in your yard and garden while the seeds left on the ground from winter will be its delight. HAPPY OBSERVATIONS!

A PEAK AT THE PAST

Father McGratty, Matchmaker

From the writings of Bernie Monaghan (1915 - 1991)

Note: When he retired from teaching, Bernie Monaghan started writing down, or we should say, typing up, the stories he had heard from the older residents of Valcartier. He also typed up church and municipal records, making them more easily available. We owe a debt of gratitude to Bernie for saving many of the early stories of the village and passing them down.

Bernie wrote:

John Corrigan's wife, Elizabeth Loughren, died August 28, 1889. He remarried in 1892. I am now going to relate how this marriage came about as related by some of the older people whom I

remembered.

As he lived on the old farm, and was quite a skilled carpenter, he was in demand to build barns and houses and at times he would be absent from home the greater part of the week, he would have someone take care of the children during his absence. Whatever the arrangement was, it did not suit Father McGratty who was Parish Priest at the time. So Father McGratty hitched his horse to the buggy and drove down to John Holton's to see if he couldn't do a little match-making. On his arrival there, he addressed himself to Catherine, the oldest daughter, still unmarried, about becoming the wife of John Corrigan, and to be a good mother to those little children. She agreed to this arrangement as Father McGratty insisted it appeared to be the Will of God in her regard.

On the following week-end, so the story goes, Father McGratty drove up to see John Corrigan and suggested that he should remarry. Mr. Corrigan admitted it was a good idea, but added wherever could he find a suitable wife at his advanced age who was willing to care for his family. The good priest explained the steps he had taken, and the marriage was blessed on the 26th of October, 1892. Two children were born of this marriage. Margaret, born July 9, 1893, and Muriel, born September 1, 1895. One can picture Father McGratty smiling to himself as he baptized those children.
